## **Key Boat Storage Conditions**

- Clearly *label the stern of the each boat* with the *boat's sail number*, *boat name and GRSC label.* (requirement of RMS)
- Annual boat storage sticker must be affixed to the stern of each boat.
- Keep boat storage area *clear and tidy*, and *use the allocated storage bay*.
- The member acknowledges they have *read the boat storage agreement*.
- The member's responsibility to *pay annual storage fees in advance of 31<sup>st</sup> October each year.*





## **Boat Storage Agreement**

By completing a Boat Storage Application Form, the member agrees:

- 1. To be bound by these terms and conditions
- 2. That Georges River 16ft Sailing Club its officers, members and other persons are in no manner liable or responsible for the loss or damage to boats or equipment however so caused, and the boats on the club premises are at the sole risk of the Member.
- 3. Acknowledges and agree that Georges River 16ft Sailing Club, it's officers, members and volunteers shall not have any liability for the loss or damage to the property whatsoever however caused arising out of the storage of any boat and that any boat is stored at my own risk. The member indemnifies Georges River 16ft Sailing Club, its officers, members and volunteers from all claims and liabilities arising from the storage of any boat by the member.
- 4. Insurance is the sole responsibility of the owner member. Please note that insurance is required to race at the Club.
- 5. Allocation of a designated storage space is at the sole discretion of the Club and the Club is at its absolute discretion may allocate an alternative space at any time during the season.
- 6. The Club, in its sole discretion, may terminate this agreement by written notice to the Member at his/her last notified address at any time for such reasons as the club may determine, including but not limited to the following:
  - a. The storage fees remain unpaid for 3 months after the due date;
  - b. The boat in not actively used; or
  - c. The Member is no longer a financial member of the Club.
- 7. The member shall remove the boat and its associated equipment from the Club within 30 days of the notice of termination.
- 8. If the Club has terminated the associated agreement by notice in writing to the Member and the Member does not remove the boat including the associated equipment from the Club premises within 30 days of the notice termination, the Member authorizes the Club as his or her agent to sell or otherwise dispose of the boat and associated equipment without notice to the member and recover from any proceeds all costs associated with the removal, storage, sale or disposal of the boat and equipment ("costs"). Any proceeds of the sale remaining after the deduction of the costs and monies owing to by the Member to the club, shall be remitted to the Member at the member's last known address. The Club may sell the boat and associated equipment pursuant to this provision in any way it deems appropriate, whether by private sale or public auction. In the event of a boat being sold the member accepts that any sale price reflects market value and shall have no recourse against the club to dispute the price.
- 9. Owners undertake to stow boats, stands, trolleys and all equipment in a tidy manner in the allocated space and to assist in keeping the storage area tidy and clean at all times.
- 10. Owners undertake to securely lock all doors when the building is unattended and to promptly return all borrowed keys. The Owner of a boat who fails to properly secure the premises at all times may be responsible for any loss or damage arising.
- 11. The club reserves the right to amend or alter these terms and conditions from year to year.
